## Soccer Policies

### S-1 Policy Regarding Player Refunds (Other than Grassroots)

Requests for refunds must be submitted in writing (e-mail, or written letter) to the Viktoria Soccer Club ([vicclub@telus.net](mailto:vicclub@telus.net)).

A full refund shall be given if the Viktoria Soccer Club is unable to field a team in that age group. No administrative fees will apply in that case, however if a player kit was issued to the player and it is not returned, the cost of the kit will be deducted from the refund.

There is no refund once a player has accepted a position on the team except under the following circumstances:

1. A paid registration, less an administration fee of \$50, shall be pro-rated\* if a player's family is transferred to another city, province, or country (written proof of transfer is required). If a player kit was issued to the player and it is not returned, the cost of the kit will be deducted from the refund. Any refund requested due to family transfer will be considered at the sole discretion of the Viktoria Soccer Club.
2. If, due to a medical condition or injury that has developed since registration, a player cannot play for the entire season, the player would be refunded on a pro-rata\* basis. This would either be applied immediately, in which case the player would get the refund less an administration fee of \$50, or the player could choose to apply the refund amount to the next season's registration. If a player kit was issued to the player and it is not returned, the cost of the kit will be deducted from the refund. The player must withdraw within 14 days of injury occurrence. A letter from a medical doctor must be provided before the Club can provide the refund or defer the refund amount to the next season. In the case of injury during league play or team practice, the ASA or the Viktoria Club Incident Report must be provided.

## Soccer Policies

### S-1 Policy Regarding Player Refunds (Other than Grassroots) cont'd

\* Pro-rated as per the following:

- If less than 25% of the season has been played, 100% of the applicable fee for the age group in question will be refunded
- If 25% and less than 50% of the season has been played, 25% of the applicable fee for the age group in question will be refunded
- If 50% and less than 75% of the season has been played, 50% of the applicable fee for the age group in question will be refunded
- If 75% or more of the season has been played, no refund will be given, and no administration fee will be charged
